



## WOMEN'S UNDER-17 QUALIFIERS

### All-Time series

#### GROUP A



**Dominican Republic vs Dominica**



Dominican Republic and Dominica will meet for the first time in the Concacaf Women's Under-17 Qualifiers.

For the Dominican Republic national team, this will be its 30th all-time match in the tournament across all rounds. It will also be match #25 in the First Round in the overall history of the Qualifiers. For Dominica, this will be match #10 in the Preliminary Round, and the team has never qualified for the Championship.

Dominica has no draws recorded in the tournament. Its two most recent matches ended in defeats (21-0 against Canada and 1-4 versus Bermuda, both in 2024). The team has recorded only one victory in its last five matches in the competition (L-4 W-1), a 1-2 win against the British Virgin Islands (26-Aug-2015, Group 3).

The Dominican Republic national team has suffered only one defeat in its last four Preliminary Round matches in the tournament (L-1 W-3), a 3-0 loss to Costa Rica (1-Feb-2025, Group F).



**Nicaragua vs Belize**



Nicaragua and Belize will meet for the first time in the Concacaf Women's Under-17 Qualifiers.

For Nicaragua, this will be its 15th match against Central American national teams, with a record of (W-1 D-1 L-12). The only victory was a 2-1 win against El Salvador in the final phase of the Preliminary Round of the 2013 tournament (June 1), in the second leg of Tie 1 (more than 12 years ago). Since that date, Nicaragua has gone on a run of six consecutive matches without a win against Central American opponents (D-1 L-5).

Belize will face Central American opponents for the sixth time in the Preliminary Round, where it has lost all matches and scored just one goal, in a 1-9 defeat against Honduras on November 11, 2015. Belize has conceded 42 goals in those games, an average of 8.2 per match.

Belize will play its 10th match in the history of the Preliminary Round of the Qualifiers. The team has achieved only two victories: a 2-1 win against Barbados on October 22, 2020, and a 3-0 win against the U.S. Virgin Islands on January 31, 2025, featuring a hat trick by **Shanalee Smith**. Belize has also recorded seven defeats.

Nicaragua will play match #16 in the Preliminary Round of the Qualifiers, holding a record of four wins, one draw, and ten losses. Its last three matches all ended in victories: a 10-0 win against the U.S. Virgin Islands on August 29, 2023; a 4-0 victory over St. Kitts & Nevis on January 28, 2025 (**Emma Quintanilla, Mariela Zavala, Stefany Miranda, Helena Lau**); and a 2-1 win against Jamaica on February 1, 2025, with goals by **Olivia Flores** and **Mitzy Canales** for Nicaragua, and **Ella Provost-Heron** for Jamaica.

This represents the best historical winning streak for Nicaragua, at least in this phase of the competition.



### U.S Virgin Islands vs Dominican Republic

The U.S. Virgin Islands and the Dominican Republic will meet for the first time in the Concacaf Women's Under-17 Qualifiers.

The U.S. Virgin Islands national team carries a streak of 15 consecutive defeats in the Preliminary Round of the Qualifiers, the longest losing streak for any national team in the history of the tournament.

The Dominican Republic will face overseas territories for the ninth time in the history of the Preliminary Round of the Qualifiers, with a record of one defeat, two draws, and five victories. The lone loss was a 3-1 defeat against Bermuda on September 21, 2013, in Caribbean Round 2 of the Preliminary Phase of that tournament (2013). The Dominican side will once again face an overseas territory national team 12 years later.

The U.S. Virgin Islands will face a Caribbean national team for the 14th time in the Preliminary Rounds of the Qualifiers, holding a record of one win, one draw, and 11 defeats, including nine consecutive losses in its most recent matches against these opponents.



### Dominica vs Nicaragua



Dominica and Nicaragua will meet for the first time in the Concacaf Women's Under-17 Qualifiers.

This will be the first time in the history of its participations that the Dominica national team faces a Central American side. The Nicaraguan national team will be the sixth different opponent that Dominica has faced in any phase of the Concacaf Women's Under-17 Qualifiers.

Nicaragua will face a Caribbean national team for the seventh time in any phase of the Concacaf Women's Under-17 Qualifiers, recording three victories and three defeats. The most recent meeting was a 0-4 loss to Puerto Rico, with **Jayla Walton, Jaeda Russel, Gabriela Garnett**, and **Journie Feliciano** scoring for Las Boricuas, in the Final Round of the Championship on April 3, 2025.

In terms of Preliminary Round matches, Nicaragua's most recent game was a 2-1 victory against Jamaica, with goals from **Olivia Flores** and **Mitzy Canales**, while **Ella Provost-Heron** scored for Jamaica, on February 1, 2025, in Group E of the Caribbean & Central America Preliminary Phase.



**Dominica vs Belize**

Dominica and Belize will meet for the first time in the Concacaf Women's Under-17 Qualifiers.

For Belize, this will be the third time facing a Caribbean national team, with one victory and one defeat. The win was a 2-1 result against Barbados in the Caribbean & Central America Preliminary Phase, Group B, on October 22, 2021, with a brace from **Khalydia Velasquez** for Belize, while **Kayghun Rouse** scored for Barbados.

The defeat was a 2-0 loss against Trinidad & Tobago in the Caribbean & Central America Preliminary Phase, Group B, on January 29, 2025, with goals by **Cherina Steele** and **Rori Grittens**.



**Nicaragua vs U.S. Virgin Islands**

Nicaragua and the U.S. Virgin Islands will meet for the second time in the Preliminary Round of the Concacaf Women's Under-17 Qualifiers. In the previous meeting, Nicaragua earned a 10-0 victory on August 29, 2023, in Group D of the Caribbean & Central America Preliminary Phase at Estadio Olímpico Félix Sánchez in Santo Domingo (DOM). **Perla Garache** scored four goals, **Aneth López** added a hat trick, and **Emma Quintanilla, Jesneyling Méndez**, and **Verónica Navarrete** also found the net. That win became the largest victory for the Nicaragua national team in the history of the tournament and the third-heaviest defeat suffered by the U.S. Virgin Islands in the competition's history, surpassed only by the two 13-0 losses against Trinidad & Tobago (August 18, 2013, and August 23, 2017) and the 22-0 defeat against Haiti (September 22, 2013).

For the U.S. Virgin Islands national team, this will be the fifth time facing a Central American opponent in the history of the tournament. The team has lost every such match, conceding 22 goals and failing to score.



## U.S. Virgin Islands vs Dominica



The U.S. Virgin Islands and Dominica will meet for the first time in the Concacaf Women's Under-17 Qualifiers.

This will mark the first time, at least since the 2018 tournament, that the U.S. Virgin Islands national team faces two Caribbean opponents in the same group in any round of the competition (DOM & DMA). On that occasion, the team suffered defeats against Trinidad & Tobago (13-0 on August 23, 2017) and Grenada (9-0 on August 25, 2017).

For Dominica, this will be the third time facing Caribbean national teams in the history of the tournament across all phases. The two previous records include one victory, a 2-1 win against the British Virgin Islands on August 26, 2015, and one defeat, a 4-1 loss to Bermuda on August 28, 2023. Dominica's goal was scored by **Le-Myah Forde**, while Bermuda's goals came from **Camryn Lines, Keyandae Lightbourne** twice, and **Avani Patton**.



## Belize v Dominican Republic



Belize and the Dominican Republic will meet for the first time in the Concacaf Women's Under-17 Qualifiers.

For the first time in the history of the tournament, Belize will face two Caribbean national teams in the same group, something that had never occurred in any of its previous participations (vs. Dominica and vs. the Dominican Republic).

This will be only the second time that the Dominican Republic national team faces a Central American opponent in any phase of the tournament. The only previous record was a 3-0 loss against Costa Rica on February 1, 2025, in Group F, with goals by **Nubia Medina, Fabiana Alfaro, and Lucía Paniagua**.



## Belize vs U.S. Virgin Islands



Belize and the U.S. Virgin Islands will meet for the second time in any phase of the Concacaf Women's Under-17 Qualifiers.

The only previous meeting was a 3-0 victory for Belize in Group B of the Caribbean & Central America Preliminary Phase on January 31, 2025, at Ato Boldon Stadium in Couva (TRI), featuring a hat trick by **Shanalee Smith**.

For Belize, this will be the third time facing a Caribbean national team in the history of the tournament. The first such match ended in a 3-1 loss against Curaçao on October 20, 2021, and the most recent was the aforementioned match against the U.S. Virgin Islands.

This will be the third consecutive time that the U.S. Virgin Islands national team faces two Central American opponents in the same group of the tournament, losing all matches. This followed encounters against Honduras in a 5-0 defeat and Nicaragua in a 10-0 loss in 2024, and against Honduras in a 4-0 defeat and Belize in a 3-0 loss in 2025.



### Dominican Republic vs Nicaragua

The Dominican Republic and Nicaragua will meet for the first time in the Concacaf Women's Under-17 Qualifiers.

For the Dominican Republic, this will be the first time in the history of the tournament that it faces two Central American national teams in the same group, something that had never occurred in any of its previous participations.

Nicaragua will face two Caribbean national teams for the second consecutive time in the history of the Qualifiers. Previously, in the 2025 edition, Nicaragua earned a 4-0 victory against St. Kitts & Nevis, with goals by **Emma Quintanilla, Mariela Zavala, Stefany Miranda, and Helenda Lau**, and a 2-1 win against Jamaica, with goals from **Olivia Flores and Mitzy Canales**, while **Ella Provost-Heron** scored for Jamaica. This represented an unprecedented achievement for the Nicaraguan national team in the Preliminary Round throughout the history of this phase.
